

KANJIZAI AFTER-CARE POLICIES & LIABILITY WAIVER

Payment Policy:

I agree to allow Kanjizai Martial Arts LLC to withdraw weekly payments or charge the credit card listed above by Friday for the following week of pickups. If I do not make a payment, I understand that Kanjizai will not pick up / drop off the student(s) listed above. If payment is not made by Friday before the program begins each week I authorize Kanjizai to deduct the amount from the credit card listed above, and if the payment cannot be deducted I agree to pay the \$10 late fee within five business days.

Initial Commitment:

A 3-month commitment to Kanjizai's before-school and after-school programs is required at registration. After the initial commitment, students may cancel anytime with 7 days notice.

Pick Up Policy:

I agree to check in at the Kanjizai Martial Arts LLC front desk by 7pm when picking up the student(s) from after-care. I will notify Kanjizai in the event that the student(s) will not need to be picked up from school or if another person is to pick up the student(s) from Kanjizai. If someone other than the parents or guardian is picking up the student(s), please call us at 410.294.4208 AND send an e-mail to KanjizaiDojo@gmail.com. If I or the person designated to pick-up the student(s) from Kanjizai is late picking up the student(s), I agree to be automatically charged the following late fees: \$10 charged for any pickup time between 7:01-7:15pm, and \$10 for every fifteen minute segment thereafter. Kanjizai Martial Arts LLC will NOT provide pickup on school days with early release times, whether scheduled or unscheduled. Parents are responsible for pickup on any day schools are released earlier than their usual release time. If school is cancelled while my child(ren) is in before-school care, I agree to pickup my child(ren) by 11:00am. If I or the person designated to pick-up the student(s) from Kanjizai is late picking up the student(s), I agree to be automatically charged the following late fees: \$10 charged for any pickup time between 11:01-11:15am, and \$10 for every fifteen minute segment thereafter.

Cancellation Policy:

In case of emergency, and your child will not be riding Kanjizai Martial Arts LLC's vehicle, please notify us as soon as possible. You will be responsible for the No call / No show fee of \$10 if you fail to notify Kanjizai before 1pm on the day of pickup. Please understand that failure of notification affects pick up procedure. **CHANGES TO A STUDENT'S PICKUP SCHEDULE MUST BE MADE 7 DAYS IN ADVANCE FOR TUITION TO BE ALTERED.**

Additional Costs:

I understand and agree that there will be special events held at the school, including but not limited to belt tests, tournaments, camps, etc., and these events may incur additional fees beyond the amounts set forth in this agreement. I also understand and agree that the cost of additional uniforms, equipment, etc., is not included and must be purchased separately.

Personal Property Policy:

I understand and agree that Kanjizai Martial Arts LLC's employees and directors shall not be held responsible for any personal property which is damaged, lost or stolen in or around Kanjizai or its facilities, or at any of Kanjizai's off-premises events and field trips.

Waiver and Release:

I, as the student(s)'s legal guardian, fully recognize that martial arts involves strenuous physical exercise and I am fully aware of the risks of injury and/or illness inherent in participation in any fitness or martial arts program, and I have taken all reasonable steps to determine, and hereby warrant, that the student(s) is(are) in good health and physically capable of participating in the programs and courses of instruction offered by Kanjizai Martial Arts LLC. I understand and agree that all participation in any such fitness program or use of Kanjizai's equipment or facilities on or off the premises, including field trips, shall be at our own risk. I authorize the personnel of Kanjizai to transport the student(s) to and from Kanjizai in any event. I hereby release, indemnify, and hold harmless Kanjizai Martial Arts LLC and its directors and employees from and against any and all claims, demands, damages, costs and liabilities of any kind or any kind of nature, including attorney's fees and costs, for any injury, harm or fatalities of myself or the student(s), or of any person(s) who become entitled to the use of the facilities of Kanjizai by virtue of this agreement, or any third persons, which arise directly or indirectly out of or in virtue of our presence at Kanjizai for any payment compensation or claim for any harm, fatalities, or injuries sustained by our presence at Kanjizai. In the case of a medical emergency I authorize Kanjizai Martial Arts LLC to seek medical attention for the student(s) listed above, and I authorize the attending physician to perform any emergency treatment that is deemed necessary.

KANJIZAI AFTER-CARE POLICIES REFERENCE SHEET

(Keep this page for your reference)

- 1. There are no pickups on days with early-dismissal, whether scheduled or un-scheduled (inclement weather, etc.)**
- 2. Notice of absence on a regular pickup day is required by 2:00pm on the day of pickup, or an additional fee of \$10 will be incurred.**
- 3. 7 days notice of absence is required for weekly tuition payments to be altered. School days with early dismissal times will not incur any charges for the day.**
- 4. Failure to pickup your child by 7:00pm will incur a \$10 late fee. An additional \$10 fee will be incurred every 15 minutes thereafter.**
- 5. An initial commitment of 3 months in the program is required at signup. After the initial 3 months, you can cancel anytime with 7 days notice.**

KANJIZAI BEFORE-SCHOOL CARE POLICIES REFERENCE SHEET

- 1. Before-School care is available from 7:00am. Students *must* arrive by 7:30am. There are no refunds if a student arrives after the Kanjizai vans depart for school drop-off.**
- 2. 7 days notice of absence is required for weekly tuition payments to be altered. There are no refunds for students who are late for Early Drop-Off.**
- 3. An initial commitment of 3 months in the program is required at signup. After the initial 3 months, you can cancel anytime with 7 days notice.**
- 4. Kanjizai's before-school care will open at 7:00am on all days with delayed school openings. In the event of a school closing, parents must pickup their child by 11:00am. There is no before-school program if school is closed, and you will not be charged for the day.**
- 5. Failure to pickup your child by 11:00am on unscheduled school closings will incur a \$10 late fee. An additional \$10 fee will be incurred every 15 minutes thereafter.**
